We Want Students To Learn and Value

- **Honesty and integrity**

- *"School is not just about learning content, it's about building character."*

- **Good work habits**

- *"Don't leave things to last minute and you won't need to panic and plagiarize."*

- **Fairness**

- *"How is your cheating fair to your peers?"*

- **Learning**

- *"If you use other people's work, you aren't learning the material."*

- **Proper acknowledgement of sources**

- *"Borrow ideas, just give CREDIT where CREDIT is DUE!"*

Academic misconduct includes:

- Plagiarism
- Collusion
- Duplication of work
- Fabrication
- Contract cheating
- Unfair advantage

Academic misconduct includes:

- **Plagiarism**
- Taking ideas or writing knowingly from another and presenting them as one's own without citing them
- **Collusion**
- Knowingly allowing another student to plagiarize one's work
- **Duplication of Work**
- Using a piece of work twice (or more) for submission
- **Fabrication**
- Inventing information, falsifying research/projects, and/or using other products with the intent to deceive.
- Ex: Falsifying data for lab report
- **Contract cheating:** work edited by or obtained from a third party: friends, family or other students; private tutors; essay writing or copy-editing services; pre-written essay banks; file sharing sites
- **Unfair Advantage**
- Any other behavior that gains an unfair advantage for a candidate
- Ex: taking unauthorized material into the exam.

What Academic Misconduct Looks Like

- Copying and pasting from a source without a citation...even if only one statement
- Paraphrasing without a citation
- Faking a citation
- Buying a paper from the Internet or another source
- Giving someone an old assignment to use
- Copying from peers
- Getting someone else to write the paper

Students: Why do we do it?

- Stress, pressure, and competition to do well in school - *"I am stressed out"*
- Poor time management skills - *"I have too many things due"*
- Students don't understand concepts of plagiarism - *"I didn't know it was plagiarism."*
- Lack of perceived consequences - *"Even if I get caught, nothing will happen."*
- My teacher won't look at the work carefully enough to catch it - *"I may get away with it."*
- Students may feel their research and writing skills are inadequate - *"I didn't think I could do a good job on my own."*
- Lack of comprehension - *"I didn't understand the material."*
- Peer pressure - *"Everyone else is doing it." "I just wanted to help my friend."*

Students: Why do we choose not to do it?

- Integrity and honesty
- It is not worth the risk
- Not wanting to disappoint parents, teachers, friends and themselves
- Understanding consequences
- Pride in work

Student's Responsibilities

- Acknowledge information from sources appropriately

- Plan ahead because thoughtful research takes time
- Use turn-it-in, a software that detects plagiarism (when requested by teachers)
- Don't just Google...use the databases
- Take advantage of extra support offered by our Librarian

Healing and Destructive Pilgrimages in Willa Cather's *Death Comes for the Archbishop* and Modern Chimayó, New Mexico

New Mexico is rightly termed the "Land of Enchantment" as it possesses a diversity of landscapes that inspire the senses. Expansive desert valleys spotted with piñon give way to massive sandstone rock formations. Imposing mountains with their blanket of green pine and aspen forests loom over desert valleys. Rounded and jagged mountain peaks and edges tower over small mountain lakes and rushing mountain streams. It is no wonder that Willa Cather, despite being widely traveled (Swift 1), "underwent a profound artistic and personal transformation" in New Mexico (Broncano 134). Like Cather, Father Latour and Father Vaillant in *Death Comes for the Archbishop* make a pilgrimage to and within New Mexico. While they suffer hardships, they find fulfillment and peace through experiencing the land and its people. Like Cather, Latour, and Vaillant, modern-day pilgrims still travel to and within New Mexico to seek healing and fulfillment.

The largest modern religious pilgrimage in the United States is centered on a little New Mexican town called Chimayó and its shrine El Santuario (Howarth 14). Long before Latour and Vaillant arrived in New Mexico, devout pilgrims flocked to the town to experience transformation and healing (Howarth 15-16). Today's pilgrims journey

Teacher's Responsibilities

- Give specific requirements as well as written examples of proper citation of a variety of sources in their discipline area(s)
- Structure assignments to encourage the development of students' own ideas through problem solving, comparison, analysis etc.
- Work within the school expectations when planning assessments in order to avoid placing unnecessary pressure on students

Parent's Responsibilities

- Provide a suitable working environment in the home
- Ensure a balance in activities (that focus on quality not quantity) so that work can be tackled in a managed way
- Ensure a balance in support that is given to children, so that the work is always in their words and there is not an overreliance on outside support
- Ask your children to discuss their work in their own words

Consequences of Academic Misconduct

- Teacher confirms with Head of Department that it is a serious case of plagiarism/cheating/collusion.
- Student is given a score of 1 for all criteria assessed
- Senior Leadership Team to contact parents
- Student required to attend a session on MLA citation with the Library Staff.
- If a student has colluded, then they will be initially counselled by the teacher and parents will be informed. If this happens again, then above consequences will be applied.
- For cheating offences, students will receive zero
- Depending on grade level, if a student has used too much of other people's work but cited correctly, they will redo the work.
